



Holiday Performance 2010

The Dance Corner is mounting its third Toys for Tots Holiday Dance Event in December of 2010. All Dance Corner students are encouraged to take part in this exciting event. Last year was so much fun and we collected 100's of toys for needy kids.

The performance will be held at the Clinton Town Hall Auditorium on Thursday, December 16th (time TBA). There will be an onstage rehearsal on Wednesday, December 15th (time TBA) as well as in studio rehearsals on Monday and Tuesday, December 13th & 14th (times TBA). Regular dance classes will not be held this week.

Students who would like to perform in our Holiday production must have been enrolled in dance classes during the 2009-2010 season and Fall 2010.

Students who want to participate in the Holiday Performance must enroll in a special "Christmas in September" session, 9/7-9/10. Our regular fall classes begin Monday, 9/13.

Students are also **STRONGLY URGED** to enroll in one summer class during the 2010 summer session. Teachers will begin working on choreography for the Holiday show during our regular summer session classes. Families with vacation plans or other conflicts with the summer class schedule, should speak with Miss Carrie. We can try to work around your vacation plans to create a class schedule that works for you. We want as many students as possible to participate, so please speak with Miss Carrie about any scheduling conflicts.

****Please note- Irish Step rehearsals for the Holiday show will be during our summer session classes- Tuesdays 6/29, 7/6 & 7/13 from 3:30-4:30PM****

Students can choose to perform in one or all styles of dance in the Holiday Performance, as long as they have been studying those styles during the 2009-2010 season. For example only students who took Irish Step class during the 2009-2010 dance year will be placed in Irish Step dances for the Holiday Performance. Since some of the younger age groups only have one style to choose from, we will make some exceptions. Speak with Miss Carrie if you're unsure about which group your child should dance with. Any dancers ages 11 & up with previous jazz experience can participate in the Hip Hop group.

Students will learn the Holiday Performance dances during the Christmas in September session. Some additional rehearsals will be scheduled in the fall, at no additional cost to dancers. Costumes for the performance will be purchased by The Dance Corner and returned to the studio after the event. Students may need to provide some basic costume pieces (e.g. scarves, leotards, clothing items you already have at home might be used as costumes). Families will pay a one-time participation fee that will cover all costs associated with their child participating in the Holiday Performance (excluding tickets to the event). Our intention is to create a fun, festive and affordable event for students and parents.

ONLY STUDENTS WHO ATTEND THE CHRISTMAS IN SEPTEMBER SESSION WILL PERFORM IN THE 2010 HOLIDAY PRODUCTION. Don't miss your chance to be a part of this event! Space is limited in each age group. Please register and reserve your spot today!
